1. **Doodhpokhari Rural Municipality** invites sealed bids or electronic bids from Nepalese eligible bidders for the construction of *Upgrading of Pyarjung Palle Road* under National Competitive Bidding procedures. The estimated amount for the works is NRs 13608614.00/- (Inclusive of PS and VAT)
2. 3. Bidder should submit their bid electronically and may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders should deposit the non-refundable fee of **Rupees Three Thousands only (NRs 3000)** for bidding document in the Project's Rajaswa (revenue) account as specified below till 14<sup>th</sup> of November 2022 and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at **Doodhpokhari Rural Municipality, Gaunda-Lamjung at 12:00 pm on 6<sup>th</sup> of November 2022.**
5. Electronic bids must be submitted to the office of **Doodhpokhari Rural Municipality, Gaunda, Lamjung** through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) or before on 15<sup>th</sup> of November **before 12:00 noon**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 pm on 15<sup>th</sup> of **Novemeber** at the office of **Doodhpokhari Rural Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs 3,50,00.00 (Three lakh fifty thousands only), which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Purchaser reserves the right to accept or reject, partly or wholly any or all of the bids without assigning any reason, whatsoever.
