The Rural Municipality has allocated funds and received a grant from Doodhpokhari Rural Municipal Executive towards the cost of **Construction of Municipal Building of Doodhpokhari Rural Municipality** and intends to apply part of the funds to cover eligible payments under the Contract for 076-77/DPRM/WORKS-01. Bidding is open to all eligible bidders as per Section V of bidding document.

- Doodhpokhari Rural Municipality** invites sealed bids or electronic bids from eligible bidders for the complete construction of Doodhpokhari Rural Municipality Building under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 36 Millions**
- Minimum Work experience of similar size and nature: **30 Millions**

- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidders should deposit the cost of bidding document **NRs. 5000.00** till **Monday, April 1<sup>st</sup> 2020 (19<sup>th</sup> Chaitra 2076)** during office hours in the Project's Rajaswa (revenue) account as specified below .

- Pre-bid meeting shall be held at Doodhpokhari Rural Municipality Office, Gaunda, Lamjung, Gandaki Province Nepal at **22<sup>nd</sup> March 2020 (9<sup>th</sup> Chaitra 2076) 12:00 hours.**
- Bids must be submitted to the office Doodhpokhari Rural Municipality through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 on 2<sup>nd</sup> April, 2020**. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at before **2:00pm on , April 2<sup>nd</sup> 2020 (20<sup>th</sup> Chaitra 2076)**, at the office of **Municipality office**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security **9,00,000 /-(NRs Nine Lakhs only)**, which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- The Employer reserves the right to accept or reject any or all the bids without assigning reason, whatsoever.

**10. Bidder should submit all required document up to date and all scanned copy should be clearly identifiable.**

**11. Bidder should submit all of their pending litigation and detail of their current running work if any.**

12. Any intimidation, collusion and curtailing during bidding process shall be punishable by law.

13. Other matters regarding the bidding process should be as per prevailing law of Government of Nepal.
